**PCCHA STALL RESERVATION & STABLING POLICIES**

- **Stall Reservations** – Must be made on or before October 1st, 2009.
- **Stall Fees** - \$139 per stall on or before October 1st. \$159 per stall after October 1st, if available.
- **Tack Rooms** – Are **highly recommended** due to location of trailer parking.
- **Trailer Parking** – All trailers will be required to park in the parking lot directly across from the main entrance to the Events Center on Riverside Ave.
- **Payment** – Must be paid in full and accompany reservations. No stall shall be considered rented unless payment in full has been received.
- **No Refunds** – There will be NO REFUNDS on Stalls or Tack Rooms.
- **No 1<sup>st</sup> Bedding** – No 1<sup>st</sup> bedding is provided.
- **Stall Bedding & Tack Room Location** - To purchase bedding prior to arrival call; J&S Feed @ (916) 996-9179. Please designate Tack Room location when ordering bedding for pre-bedding purposes.
- **Pre Bedding** – Stalls will be pre-bedded prior to your arrival.
- **Move In Date** – **Tuesday, October 20, 2009. Move in will not be allowed prior to this date.**
- **Arrivals** – Our Welcoming Committee will be on hand to assist with your stabling & unloading needs. It will more than likely be very busy the first few days. Your patience and understanding will be greatly appreciated.
