

# 2012 DERBY

## Non Pro & \$200,000 Limited Non Professional

### RULES AND REGULATIONS

1. For Four year - olds (foals of 2008) all breeds.
2. The Derby will be held in three divisions: Open, Non-Professional and \$200,000 Limited Non Professional. Within the Non Professional division as a class within a class will be the \$10,000 Novice Horse Division. Within the \$200,000 Limited Non Professional division as a class within a class will be the \$100,000 Non Pro division and the \$10,000 Novice Horse Division. The go-round Trials for the Non Pro and the \$200,000 Limited Non Pro Divisions shall be drawn and worked separately. A Non Pro so qualifying for both divisions may enter both divisions. A horse may be entered in any and all divisions. Eligibility for the \$200,000 Limited Non Professional is based on Lifetime Earnings as of January 1, 2012. Eligibility for the \$100,000 Limited Non Professional is based on Lifetime Earnings as of January 1, 2012
3. Nomination Fees for NON PRO division with an added purse of \$15,000

Nomination Fees for \$200,000 NON PRO division. One go-round and Separate Finals, with an added purse of \$10,000

\*\*P/C – Purse Contribution – should residuals exist; they would be applied to the cost of the event.

\$100,000 Non Pro Division within the 4 Year old \$200,000 Non Pro Division. Jackpot entry fee \$500 (\$400 JP/\$100 O/C).

\$10,000 Novice Horse Division within the 4 Year-old Non Pro and \$200K Non Pro Divisions. Jackpot entry fee \$500 (\$400 JP/\$100 O/C). Eligibility for the \$10,000 Novice Horse Division based on Lifetime Earnings as of January 1, 2012.

Senior Division within the 4 Year old Non-pro and \$200K Non Pro Divisions (55 yrs. or older). Jackpot entry fee \$500 (\$400 JP/\$100 O/C).
4. Entries are taken and processed per PCCHA aged event entry rules.
5. Owner may enter as many horses as they choose. Non Pro and \$200,000 Limited Non Pro riders may ride as many horses as he/she chooses in their respective divisions.. A Professional may ride the horse in the Open division and the owner (Non Pro or \$200,000 Limited Non Pro so qualifying) may ride the same horse in the Non Pro and/or \$200,000 Limited Non Pro divisions.
6. Trials: All horses entered in each division will work in the Trials to be held before the actual event, provided they meet all previously stated requirements. The Trials shall consist of two go-rounds for the Non Pro division and one go round (first go round only) for \$200,000 Limited Non Pro division. Four (4) head of cattle per horse will be used. The top scoring 60% of the first go-round of the Non Professional will advance to the second go-round, except those horses that mark a 0 or 180 shall not advance further.
7. Semifinals: The top forty percent (40%) with a minimum of thirty (30) horses that have competed in both go-rounds of each division's Trials may advance to the Semifinals of each division. In the event that there are less than one hundred fifty (150) horses in a division of the Trials, there will be no Semifinals for that division, (however, under no circumstances will there be held a semifinals for the \$200,000 Limited Non Pro division), and the high

scoring 20% (with a minimum of 8 and a maximum 25) of the entries based on the number of horses drawn for the first go-round of the Trials may advance directly to the divisions' finals. Each entry so qualifying for the divisions' Semifinals shall be paid the amount of the original nomination fee less video fee, turnback stall fee, drug fee and any late fees. In the event that a Semifinal is not held for a division, every contestant qualifying for the finals will be paid the original nomination fee less video fee, turnback stall fee, drug fee and any late fees. The top fifteen (15) entries will be eligible to advance to the Finals in their division.

8. Finals: In the Non Professional division and the \$200,000 Limited Non Professional division, the high scoring 20% (with a minimum of 8 and a maximum of 25) of the entries based on the number of horses drawn for the first go round of the Trials will advance to the finals. In the event there are fewer than 20 entries in a division, a minimum of six (6) horses advance to the finals.
9. Working Finals: Four (4) head of cattle per horse will be used. The purse for each division finals will consist of the entry fees plus the added purse which shall be divided according to the terms of paragraph #3 above. Finalists will be paid based on scores in the finals only to determine the placings. In the event of ties advancing to the finals, all finalists will receive money.
10. After the official announcement of horses qualifying for the Finals, there shall be no additions or substitutions for any reason. If a qualifying horse is unable or prevented from competing, the owner thereof shall be responsible for payment of any additional fees owed.
11. The five (5) judge monitor system shall be used throughout.
12. If there are any ties for the Championship of a PCCHA event the purse will be distributed 50/50. A work off will be held *only* to determine the recipient of the awards, if the competitors so choose.
13. Non Pro, Limited Non Pro and \$50,000 Am Senior (55 years & older) and Open, Non Pro, Limited Non Pro and \$50,000 Am Gelding Divisions: Entry fees for the Senior Division jackpot will be \$500 (\$400 jackpot/\$100 office) and entry fees for the Gelding Division jackpot will be \$500(\$400 jackpot/\$100 office) due on Feb. 10, 2012. Payouts will be in order of advancement according to NCHA Payout Schedule.
14. Vogt Buckles will be awarded to the Champion and Reserve Champion in all three divisions.
15. The PCCHA executive committee reserves the right should it be deemed necessary, to make any changes or alterations to the above rules.
