## Open and Non Professional

### THREE-YEAR-OLD RULES AND REGULATIONS

1. For three-year-olds (foals of 2015) all breeds.
2. The Pacific Coast Cutting Horse Association Futurity will be held in two divisions: Open and Non-Professional. A horse may be entered in any or all divisions.
3. Nomination Fees for **OPEN** division will have **\$80,000** added purse (2 go rounds / Finals)

4. Entries are taken and processed per PCCHA Aged Event Entry Rules. All Owners and Riders must be current PCCHA/NCHA members to compete.
5. Owners may enter as many horses as they choose. Open and Non Pro riders may ride as many horses as they wish in their respective divisions. A Professional may ride the horse in the Open Division and the owner (Non Pro) so qualifying may ride the same horse in the desired division or divisions.
6. **Trials:** All horses entered in each division will work in the Trials to be held before the actual event, provided they meet all previously stated requirements. The trials shall consist of two go-rounds for the Open and Non Pro divisions. Three and a half (3.5) head of cattle per horse will be used in the Open and Non Pro divisions throughout.
  - **Open:** The top scoring sixty (60%) percent of the Open first go round will advance to the second go round.
7. **Semifinals:** The top thirty (30%) percent with a maximum of fifty (50) horses that have competed in the first go rounds of the division trials may advance to the Semifinals. The high-scoring forty (40%) percent of the entries shown in the Semifinals will be eligible to advance to the Finals, with a minimum of ten (10) and a maximum of twenty (20). Each entry so qualifying for the divisions' Semifinals shall be paid the amount of the original nomination fee less the video fee, turn back stall fee, drug fee and any late fees.
  - **Open Semifinals:** 150 entries required in order to have an Open Semifinals. In the event there are less than one hundred fifty (150) horses in the division of the Trials there will be no Semifinals for that division.
8. **Finals:** Four (4) head of cattle per horse will be used in the Open and Non Pro divisions in the finals. The purse for each division finals will consist of the entry fees plus the added purse which shall be divided according to the terms of paragraph #3 above. In the event of ties advancing to the Finals, all finalists will receive finalist money. Finalists will be paid based on scores in the finals only to determine placing.
  - **Open Working Finals:** In the event of no semi-finals, the high-scoring twenty (20%) percent, from the 1<sup>st</sup> go round, (with a minimum of eight (8) and maximum of twenty five (25) of the entries based on the number of horses drawn for the first go-round of the Trials may advance directly to the divisions' finals. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round(s) and no separate finals.
  - **Non Pro Working Finals:** The high-scoring twenty five (25%) percent, from the 1<sup>st</sup> go round, (with a minimum of eight (8) and maximum of twenty (20) of the entries based on the number of horses drawn for the first go-round of the Trials may advance directly to the divisions' finals. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round(s) and no separate finals.
9. After the official announcement of horses qualifying for the Semifinals or Finals, there shall be no additions or substitutions for any reason. If a qualifying horse is unable or prevented from competing, the owner thereof shall be responsible for payment of any additional fees owed.
10. The five (5) judge Adjusted Score Monitor system shall be used throughout.
11. If there are any ties for the Championship of a Pacific Coast event the purse will be distributed 50/50. In case of ties in the Finals, awards go to the contestant with the highest accumulative score in the go rounds and finals.
12. Skyline Buckles will be awarded to the Champion and Reserve Champion in the Open and Non-Pro divisions.
13. **Open and Non Pro Gelding Division:** There will be a Gelding Division within the Open and Non Pro. Entry fee for the Gelding division will be \$500 (\$400 jackpot/\$100 office). May enter these divisions up until class begins. Payouts will be made to the highest advancing and paid according to NCHA Payout Schedule
14. **Non Pro Senior division:** A Senior division (60 years or older) jackpot will be held within the Futurity Non Pro division. The entry fee will be \$500 (\$400 jackpot/\$100 office). May enter these divisions up until class begins. The senior division will be paid in order of advancement according to the NCHA payout schedule.
15. The PCCHA Executive Committee reserves the right should it be deemed necessary, to make any changes or alterations to the above rules.

# 2018 Futurity Open and Non Pro Intermediate Rules & Regulations

1. For three year olds (foals of 2015) all breeds.
2. Nomination fees for \$10,000 added Intermediate Open
  - a. On or before Sept 5, 2018.....\*\$1,250.00
  - b. \*Includes E/F/\$601-CC/\$427-OC/\$200-\$12 Video Fee-\$10 Turn Back Horse Stall Fee
3. Nomination fees for \$5,000 added Intermediate Non Pro
  - a. On or before Sept 5, 2018.....\*\$1,150.00
  - b. \*Includes E/F/\$551-CC/\$427-OC/\$150-\$12 Video Fee-\$10 Turn Back Horse Stall Fee
4. Entries are taken and processed per PCCHA aged event rules.
5. Go round will run concurrently with the Open 2<sup>nd</sup> go round – Separate Finals.
6. A rider may enter the Open and/or Non Pro Intermediate **and/or** the Open and/or the Non Pro divisions. (If entering both divisions, a discounted entry fee with an adjusted cattle charge will be offered, as the same horse cannot ride to the herd twice in the 2<sup>nd</sup> go round.)
7. **Rider Qualifications:**
  - a. Within previous two show years immediately preceding the desired year of competition, rider has not won in excess of \$200,000 LTE monies per NCHA rules for those combined calendar show years. In the event a rider has earned over \$200,000 in the preceding two years, the rider is ineligible for the year, but may qualify for the following years if he meets the criteria again. (Based on earnings as of 5/1/2018)
  - b. No Hall of Fame riders may qualify, until aged 60, once a rider reaches the age of 60 he may rollback into the IM unless he does not meet the \$200K LTE over calendar show years.
8. Trials: All horses entered will work in the Trial to be held before the actual event. The trial shall consist of one (1) go round. Three and a half (3.5) head of cattle will be used per horse. The top scoring 25% will advance to the finals; with a maximum of 20. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round and no separate finals.
9. Final: Four (4) head of cattle per horse will be used. The purse for the final will consist of the entry fees plus the added purse. Finalists will be paid based on scores in the final only to determine the placing.
10. After the official announcement of horses qualifying for the Finals, there will be no additions or substitutions for any reason. If a qualifying horse is unable or prevented from competing, the owner thereof shall be responsible for payment of any additional fees owed.
11. The five (5) Judge Monitor system shall be used throughout.
12. If there are ties for the Championship of a PCCHA event the purse will be distributed 50/50. To determine the recipient of the awards, the award goes to the highest accumulative score of the event.
13. Skyline Buckles will be awarded to the Champion and Reserve Champion.
14. The PCCHA executive committee reserves the right should it be deemed necessary, to make any changes or alterations to the above rules.

## Unlimited Amateur

### THREE-YEAR-OLD RULES AND REGULATIONS

1. For three-year-olds (foals of 2015) all breeds.
2. \$10,000.00 added money
3. Nomination fees for Classic/Challenge Unlimited Amateur  
On or before Sept. 5, 2018.....\*\$1,250.00  
\*Includes \$428 Cattle Charge; \$200 O/C; \$600 E/F; \$12 Video Fee; \$10 Turn Back Horse Stall Fee.
4. Entries are taken and processed per PCCHA aged event rules.
5. Amateurs may ride as many horses as they choose.
6. All entrants must be designated an Unlimited Amateur by NCHA rules and records and hold an NCHA Amateur card.
7. Trials: All horses entered will work in the Trial to be held before the actual event. The trial shall consist of one (1) go round. Three (3) head of cattle will be used per horse. The top scoring 25% will advance to the finals; with a minimum of 8 and a maximum of 20. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round(s) and no separate finals.
8. Final: Three and a half (3.5) head of cattle per horse will be used. The purse for the final will consist of the entry fees plus the added purse. Finalists will be paid based on scores in the final only to determine the placing.
9. After the official announcement of horses qualifying for the Finals, there will be no additions or substitutions for any reason. If a qualifying horse is unable or prevented from competing, the owner thereof shall be responsible for payment of any additional fees owed.
10. The five (5) Judge Monitor system shall be used throughout.

The rider may not have won in excess of \$100,000 Lifetime earnings and must hold and NCHA Amateur card. Entry fees are \$500 (\$400 jackpot/\$100 office.) May enter this division up until class begins. Skyline Buckles will be awarded to Champion, Reserve Champion and all finalists. Payouts will be made to highest advancing and paid according to NCHA Payout Schedule.
14. **Senior and Gelding Divisions:** There will be a Senior (60 yrs. and older) and a Gelding Division within the Unlimited Amateur division. Entry fees for these classes within a class jackpots will be \$500 (\$400 jackpot/\$100 office). May enter these divisions up until start of class. Payouts will be in order of advancement according to NCHA Payout Schedule.

2. The Cutting Stakes will be held in two divisions: Open and Non-Professional. The go-round Trials for the Open and Non Pro Divisions shall be drawn and worked separately. A horse may be entered in any and all divisions.
3. Nomination Fees for **OPEN** division with an added purse of **\$50,000**

  - \$10,000 Novice Horse** Division within the 4 Year-old Open and Non Pro Divisions. Jackpot entry fee \$500 (\$400 JP/\$100 OF.) Eligibility for the \$10,000 Novice Horse Division based on Lifetime Earnings as of September 1, 2018.

  - Open:** The top scoring sixty (60%) percent of the Open first go round will advance to the second go round.
  - Non-Pro:** The top scoring sixty (60%) percent of the Non Pro first go round will advance to the second go round.\*\*No horse shall advance in either the Open or Non Pro that mark a 0 or 180.
7. **Semifinals:** The top thirty (30%) percent with a maximum of fifty (50) that have competed in the first go rounds of the division trials may advance to the Semifinals. The high-scoring forty (40%) percent of the entries shown in the Semifinals will be eligible to advance to the Finals, with a minimum of ten (10) and a maximum of twenty (20). 5. Amateurs may ride as many horses as they choose.
6. All entrants must not have won in excess of \$100,000 Lifetime earnings and hold an NCHA amateur card.
7. Trials: All horses entered will work in the Trial to be held before the actual event. The trial shall consist of one (1) go round. Three (3) head of cattle will be used per horse. The top scoring 30% will advance to the finals; with a minimum of 8 and a maximum of 20. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. 5. Owner may enter as many horses as they choose. Open & Non Pro riders may ride as many horses as he/she chooses in their respective divisions. A Professional may ride the horse in the Open division and the owner (Non Pro so qualifying) may ride the same horse in the Non Pro division.
6. Trials: All horses entered in each division will work in the trials to be held before the actual event provided they meet all previously stated requirements. The Trials shall consist of two go-rounds for the Open and Non Pro divisions. Three and a quarter (3.25) head of cattle per horse will be used in the Open and Non Pro go rounds. The top scoring 60% of the first go-round will advance to the second go-round, except those horses that mark a 0 or 180 shall not advance further. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round(s) and no separate finals.
7. **Semifinals:** The top thirty (30%) percent with a maximum of fifty (50) that have competed in the first go rounds of the division trials may advance to the Semifinals. The high-scoring forty (40%) percent of the entries shown in the Semifinals will be eligible to advance to the Finals, with a minimum of ten (10) and a maximum of twenty (20). Each entry so qualifying for the divisions' Semifinals shall be paid the amount of the original nomination fee less the video fee, turn back stall fee, drug fee and any late fees.
  - **Open Semifinals:** 150 entries required in order to have an Open Semifinals. In the event there are less than one hundred fifty (150) horses in the division of the Trials there will be no Semifinals for that division.
  - **Non Pro Semifinals:** 125 entries required in order to have a Non-Pro Semifinals. In the event there are less than one hundred twenty-five (125) horses in the division of the Trials there will be no Semifinals for that division.
8. **Finals:** Three and a half (3.5) head of cattle per horse will be used in the Open and Non Pro divisions in the finals. The purse for each division finals will consist of the entry fees plus the added purse which shall be divided according to the terms of paragraph #3 above. In the event of ties advancing to the Finals, all finalists will receive finalist money. Finalists will be paid based on scores in the finals only to determine placing.
  - **Working Finals:** In the event of no semi-finals, the high-scoring twenty (20%) percent, from the 1<sup>st</sup> round, with a minimum of eight (8) and maximum of twenty five (25) of the entries based on the number of horses drawn for the first go-round of the Trials may advance directly to the divisions' finals. If there are fewer than 25 entries in a division, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there shall be a non-working finals based on the total aggregate score(s) from the go round(s)
9. After the official announcement of horses qualifying for the Semifinals or the Finals, there shall be no additions or substitutions for any reason. If a qualifying horse is unable or prevented from competing, the owner thereof shall be responsible for payment of any additional fees owed.
10. The five (5) judge monitor system shall be used throughout.
11. If there are any ties for the Championship of a PCCHA event the purse will be distributed 50/50. To determine the recipient of the awards, the award goes to the highest accumulative score of the event.
12. Open, Non Pro, Gelding & \$10,000 Novice Divisions and Non Pro Senior Division: There will be an Open and Non Pro \$10,000 Novice & Gelding Division and a Non Pro Senior (60 yrs. and older) Division within each of the named divisions. Entry fees for these Division jackpots will be \$500 per division (\$400 jackpot/\$100 office) May enter up until class starts. \$10,000 Novice eligibility based on Total Lifetime Earnings as of September 1, 2018. Payouts will be in order of advancement according to NCHA Payout Schedule.
13. Skyline Buckles will be awarded to the Champion and Reserve Champion in all three divisions.

6. All entrants must not have won in excess of \$100,000 in Lifetime Earnings and hold an NCHA Amateur card.
7. Trials: All horses entered will work in the trial to be held before the actual event. The trial shall consist of one (1) go round. Three (3) head of cattle will be used per horse. The top scoring 30% will advance to the finals; with a minimum of 8 and a maximum of 20. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round(s) and no separate finals.

6. All entrants must be designated an Unlimited Amateur by NCHA rules and records and hold an NCHA Amateur card.
7. Trials: All horses entered will work in the Trial to be held before the actual event. The trial shall consist of one (1) go round. Three (3) head of cattle will be used per horse. The top scoring 25% will advance to the finals; with a minimum of 8 and a maximum of 20. In the case that there are less than 25 entries, a minimum of six (6) horses will advance to the finals. In the event there are less than 20 horses, there will be a pencil finals (non-working) after the go round(s) and no separate finals.
