

## PCCHA YOUTH HALL OF FAME AWARD

Nominations Due July 1<sup>st</sup>!

PCCHA YOUTH HALL OF FAME:

The PCCHA Youth Hall of Fame has been established to recognize those individuals who have made outstanding and unusual contributions to the PCCHA and its basic purpose and philosophy, which is the public exhibition and constant promotion of the Cutting Horse throughout the Pacific Coast Region. Those so honored will be those individuals who have exhibited a high moral character, good sportsmanship, fairness and an exemplary contribution of time, effort and interest in working towards the short and long term goals of PCCHA.

Letters of nomination will be accepted from the membership at large prior to \*July 1' of each year, which shall nominate members (past or present, living or deceased) who that member feels is qualified for induction into the Youth Hall of Fame. Letters of nomination should contain a brief Cutting Horse biography of the proposed inductee and a summary of his/her contributions or other basis for induction.

To be eligible, nominated members must have been in the past an active PCCHA youth cutting participant, who has advanced out of the youth (living or deceased) and achieved High School diploma or GED equivalent.

Each year the PCCHA President shall appoint a committee consisting of 5 members, at least three of whom shall be Officers or Directors who will screen the nominations and submit a list of recommended inductees to the Board of Directors who will make the selections.

If a Nominee is not so recommended, the Nominee must be re-nominated in order to again gain consideration for induction.

Induction ceremonies shall take place during PCCHA Youth year End Awards.

## CLARK MILLER SPORTSMANSHIP AWARD

The Clark Miller Sportsmanship Award has been established to recognize those individuals, who as current youth members, have made outstanding contributions to the basic purpose and philosophy of the PCCHA and/or PCYCHA. Those current youth members so honored will be individuals who have exhibited high moral character, peer leadership, fairness and a positive attitude, with an emphasis placed on members who have displayed extremely high levels of sportsmanship and who have consistently shown compassion to their equine partners.

The intention of this award is to honor youth members based upon each current year rather than a historical body of work. Criteria to determine recognition of these youth individuals will be based upon attitude towards trainers, friends, adults, contributions towards the association, etc. The success in the cutting arena of a nominee is not part of the criteria; however, the nominee's attitude towards fellow competitors, trainers, members of the association and the nominee's contributions to the association over the subject year will be considered.

Letters of nomination will be accepted from the PCCHA membership at large prior to July 1<sup>st</sup> of each year. Letters of nomination should contain a brief biography of the proposed youth recipient and a summary of his/her contributions or other basis to receive said award.

The committee appointed by the PCCHA president to consider PCCHA Youth Hall of Fame induction shall also receive any nominations for the award. Said committee will screen the nominations and submit a list of recommended recipients to the Board of Directors who shall make the selections.

The ceremonies to receive said award shall take place during the PCCHA Youth Year End Awards. There shall be no minimum or maximum number of recipients each year nor shall there be a limit on the number of times, consecutive or otherwise, that a nominee can receive said award.
